Excused Absence to Attend Benefits Fairs

Subject to supervisory approval, employees may be granted no more than two hours of administrative leave in order to attend one of the health benefits fairs occurring throughout the District government during the open enrollment period. If an employee requires more than two hours of leave, the employee must request and be approved for annual leave, leave without pay, compensatory time off, or exempt time off, as appropriate.
